As an applicant to the Community Arts Center's Fine Arts & Crafts Festival I accept the decision of the Jury of Selection and will exhibit per regulations if selected.

Applicant hereby releases the Community Arts Center, Swarthmore Town Center, the Borough of Swarthmore and Delaware County Council, the staffs and associates from any and all responsibility, personal liability (injury), loss damage or legal action that may arise or occur to exhibitor, his/her goods, property or the public from any condition whatsoever during the preparation and set-up and duration of the festival under this agreement.

The applicant is solely responsible for the selling of his/her items and any other conduct of business including, but not limited to, any and all related taxes.

The applicant is solely responsible for his/her person and property during said festival and maintains insurance, if desired, at his/her expense.

This application for entry constitutes an agreement on the part of the applicant that he/she accepts the above said statements as detailed.

I also confirm that the work entered and exhibited is created by me, as required under the Community Arts Center's Fine Arts & Crafts Festival regulations.

INFORMATION FOR APPLICANTS

Work will be accepted in the following categories: Drawing and Pastels, Graphics and Printmaking, Oil and Acrylic, Watercolor, Mixed Media, Ceramics, Glass, Sculpture, Fibers, Wood, Jewelry and Metal, Photography, Digital media.

The artist must be present for the entire day of the festival and will be responsible for the sale of her/his work. No agents, dealers or merchants are permitted.

All work exhibited must be created by the entrant. No mechanical or digital reproductions (prints) of hand made work will be accepted. (including notecards, calendars or other small reproductions). Hand-pulled art prints (serigraphs, etchings, etc. printed by the artist) will be accepted. Archival digital prints of digital photography and other work that is created using digital media (digital art) will be accepted.

Each work exhibited at the Festival must be clearly labeled with the price. There are no commissions charged by the Community Arts Center on any sales.

Unacceptable items include: imported work of any type, work created by a person other than the artist, greenware pottery, sculpture from molds, handicrafts, mass produced factory art, reproductions on notecards or postcards as well as any other items deemed by the committee to not fall within the spirit of the festival requirements. Selected artists may NOT display OR sell these items at the Community Arts Center's Fine Arts and Crafts Festival.

Applicants must submit the following for consideration of the jury: a CD or USB flash drive with four (4) digital images in jpg format. Images must be a minimum of 150 dpi saved to highest level, with the longest dimension being 900 pixels or less. Please label each image with last name, first initial, and number corresponding to the entry number on your form. (e.g. SmithJ1)

Applicants MUST include a self-addressed, stamped envelope with their application for the return of application materials and the jury's decision. No entry materials will be returned without a SASE.

Exhibitors will be permitted to exhibit only the specific type of work submitted to the jury. If entering in more than one category, please submit clearly state that in application and include examples of each type. *As an example, jewelry cannot be exhibited with another medium unless approved by the jury.*

A non-refundable jury fee of \$20 is required and must be submitted with the properly completed application and the required photos. In addition, applicants should include a check for space rental (\$100 for CAC members/ \$110 for non-members).

Selected exhibitors will be assigned a 10' X 10' space on Park Avenue or Dartmouth Ave in Swarthmore, PA. Each exhibitor must bring everything needed for display.

The Community Arts Center will return the booth fee checks of any applicant NOT accepted to exhibit in the festival. Materials of selected exhibitors will be returned the day of the festival. Each selected exhibitor will receive festival invitations to distribute.

Completed applications must be received by the Community Arts Center no later than APRIL 7, 2017. Artists will be notified of the jury's decision by MAY 5, 2017. If an exhibitor must cancel, 50% of the exhibition fee will be refunded prior to August 1, 2017. There will be no refunds for cancellations after August 1, 2017.
